Coats for Kids School Video Contest

Terms and Conditions

- **1.** All entries must be in a digital video format.
- 2. Each entry must focus on at least one of following:
 - Why your school participates in Coats for Kids
 - What students have learned by participating in Coats for Kids
 - How your school collects coats for Coats for Kids
- **3.** The length of the video should not exceed 120 seconds (two minutes), not including the 10 second title screen (see #4).
- 4. All entries should begin with a 10 second full-screen "title screen" that includes the following information:
 - School name
 - School city, state
 - Title of video
 - Grades of School (i.e.: Elementary School (K-5), Middle School (5-8), High School (9-12)
- 5. Participating schools must be currently active as a school collection partner for the 20th annual Coats for Kids program, which runs October 12, 2015 -January 8, 2016.
- 6. Any information presented in the video must be cited, giving credit to the original source. Plagiarism of any kind will result in disqualification. IF CHOSEN AS A FINALIST, you must submit a list of your sources, properly cited. Finalists will be chosen by a team of Coats for Kids affiliates.
- 7. While several students may work together on the project, it must be submitted under only one name. Any prizes will be awarded to the winning school.
- 8. There is no entry fee.
- **9.** Entries may be submitted through the Coats for Kids website (www.antons.com/cfk) starting on October 12, 2015. The deadline for submissions is 5:00 pm (eastern time, US) on Friday, December 18, 2015.
- **10.** No copyrighted materials (music, images, etc.) may be used for this contest unless you own the copyright or have a license to use the material for this contest. Written permission must be obtained and provided upon request for all copyrighted materials.
- 11. All portions of the online entry form must be completed when you upload your video for it to be eligible.
- 12. If chosen as a finalist, you must submit a signed/completed Parent Permission Form and a signed/completed Actor Release Form for each person appearing in your video. - **13.** Content must comply with all local and national laws of the country of origin and the United States. Content must not 1) promote illegal behavior; 2) support racial, religious, sexual or other invidious prejudice; 3) advocate sexual or violent exploitation; 4) violate rights established by law or agreement; 5) invade the privacy of any person; or 6) be otherwise inappropriate as determined by Coats for Kids in its sole and conclusive determination.
- 14. The judges' decision is final. Entries will be judged by topic and content, with winners in each of the three age ranges (Elementary [k-5], Middle [5-8], and High School [9-12]). Any schools containing all age ranges k-8 or k-12 will be considered "Middle School". Finalists will be chosen by the 501c(3), Caring Partners, Inc., board members.
- **15.** The only compensation for submitting a video is the opportunity to be awarded a prize if the entry wins. Coats for Kids will pay filmmakers no additional compensation nor be liable to the filmmaker under any circumstances.
- 16. Awards will be presented as follows:

Elementary

- One (1) First Place: \$250 gift card towards school supplies, trophy to display at the school, video displayed on website and social media
- Two (2) Honorable Mentions will receive a \$50 gift card towards school supplies and a trophy to display at the school
- All Participants: Certificate of participation

Middle

- One (1) First Place: \$250 gift card towards school supplies, trophy to display at the school, video displayed on website and social media
- Two (2) Honorable Mentions will receive a \$50 gift card towards school supplies and a trophy to display at the school
- All Participants: Certificate of participation

High School

- One (1) First Place: \$250 gift card towards school supplies, trophy to display at the school, video displayed on website and social media
- Two (2) Honorable Mentions will receive a \$50 gift card towards school supplies and a trophy to display at the school
- All Participants: Certificate of participation
- **17.** Students should keep at least one copy of their video. Coats for Kids is not responsible for any films that are lost, damaged, or that do not upload properly.
